If your health care organization is looking to improve or expand your HIV prevention services, we can provide **free** training and TA to support your efforts.



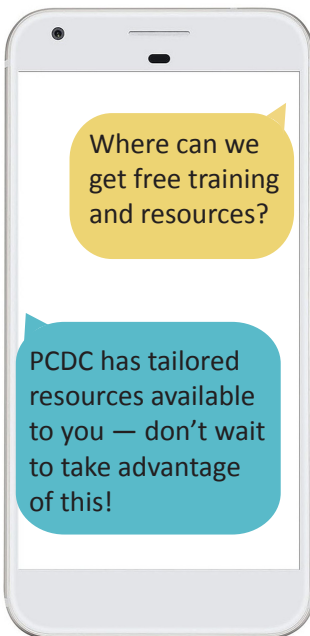
PCDC's trainings are customizable to meet the specific needs of your health care organization and can be delivered in-person or via a web-based platform.

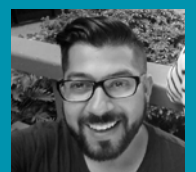
